Organized in July 1974 by approximately 20 enlisted personnel in Lynchburg, VA. Incorporated at the First Annual Conference in March 1975 as a non-profit organization.

The first President was State Command Sergeant Major Lewis.

Some of the benefits and privileges that the Va A/ANGEA promoted and helped to achieve:

- County or City decals for no more than the cost of National Guard plates
- Up to \$3000 of National Guard pay exempt from Virginia state income taxes
- Commissary privileges
- Scholarships sponsored by VaA/ANGEA and the Ladies Auxiliary

Annual membership consists of enlisted members of the VA Army/Air National Guard and Retirees who submit application and make payment of prescribed dues. Annual membership is for a full year from the date of the application.

NAME

This association shall be known as The Virginia Army/Air National Guard Enlisted Association, also referred to as VaA/ANGEA. It is established as a non-profit organization.

PURPOSE

To enhance the prestige, morale and wellbeing of the retired and enlisted members of the Virginia Army/Air National Guard.

To facilitate the exchange of ideas and the solution of problems relating to the enlisted and retired members of the Virginia Army/Air National Guard.

To provide a method for the individual enlisted or retired member of the Virginia Army/Air National Guard to propose resolutions which can be acted on by the Association to improve various aspects of the Virginia National Guard.

To encourage and provide a vehicle for fraternal and social activities for enlisted and retired members of the Virginia Army/Air National Guard.

To promote and support adequate State and National security under to provisions of the Constitution of the State of Virginia and the Constitution of the United States of America.



EANGUS ACCOMPLISHMENTS

Among the many noteworthy accomplishments of EANGUS, largely attributable to the Associations grass roots and legislative efforts are:

- VA Home Loan Program for Guard and Reserve members made permanent
- DoD Dental Insurance plans for Retirees and National Guard Members
- Burial Benefits for National Guard Members
- Unlimited Commissary privileges for Guard and Reserve Members
- Small Business Administration loans for mobilized Guard and Reserve Members
- Montgomery GI Bill education benefits increases and improvements
- TRICARE benefits for National Guard members who are unemployed or without employer sponsored health insurance
- Restoration of tax-deductibility of non-reimbursable expenses for travel to drill
- Extended protections under the Soldiers' and Sailors' Civil Relief Act for National Guard Members
- Increase in IADT points that can be earned in one year.
